Our Lady Queen of Heaven School takes top prizes in video contests

ing has always been around, but it seems to have gotten out of control in recent years. The recent outbreak of children and teens committing suicide as a direct result of being bullied has lead to the coining of the word "Bully-

Bullycide is a nationwide problem, and something must be done to stop this epidemic. That is where Our Lady Queen of Heaven Catholic School (OLQHS) stepped forward. Last fall, OLQHS started an anti-bullying club called Students With Antibullying Goals or SWAG. The organization is all about putting the power for positive change in the hands of those that are affected the mostour youth! SWAG instills in the students that they must be *Upstanders* - people who prevent, stop, and heal the harm that bullying causes for everyone.

Among other projects, and with the guidance from local news celebrity, Pam Dixon, SWAG created an anti-bullying themed video with the purpose of entering it into two national contests.

In the video, students promote a message of standing together, and not backing away from doing what is right. The school and the students were they took the top spot in both competitions.

SWAG captured The Catholic Mutual Group's Grand Prize of \$10, 000. The second contest win, came from The National School Climate Center's (NSCC) BullyBust Campaign partnered with the Blockbuster Broadway musical Wicked, and sponsored the "For Good" Video Contest. As the Grand Prize winner the school will receive a \$500.00 grant from BullyBust to continue their excellent bully prevention efforts. In addition, this fall, select cast members from the Broadway production of Wicked will make a special visit to

Sue Ellen Stokeld, school counselor and moderator for the video contest, since the beginning of SWAG said, "OLQHS has become a SAF-ER place where bullying is no longer acceptable. The school's conversation has changed. SWAG has brought together students, teachers, faculty, parents, and friends all working towards a unified goal of creating the SAFEST environment for everyone in the community."

The Rev. Mitchell P. Semar is a 40-year old native of Vinton. He is the son of LeRoy and Judy Semar, and the youngest of four children. He has two sisters, Anne and Stephanie and one a brother, Chris. He graduated from Vinton High School and attended Notre Dame Seminary in New Orleans where earned a master's of divinity degree.

As part of his priestly ministry, he ministered at St. Hilary of Poitiers Church in Mathews in the summer of 2006 and at St. Anthony of Padua Church in Bayou Black in the summer of 2009. From June to October 2011 he served his deacon internship at Our Lady of the Most Holy Rosary Church in Houma.

Prior to his ordination, May 26, Semar was quoted in the Bayou Catholic (the monthly newsmagazine of the Diocese of Houma-Thibodaux), saying, "I can't wait to serve the Church of Houma-Thibodaux by celebrating the sacraments and being there for important times, as well as ordinary times, in people's lives. Mass, Rally held for Fortnight for Freedom

SULPHUR - Father Edward Richard, M.S., pastor of Our Lady of Prompt Succor Catholic Church in Sulphur, spoke about Religious Liberty in his homily last Sunday during the Mass for Freedom celebrated by Bishop Glen

The Mass, along with last Saturday's Standup for Freedom Rally on Sulphur's Heritage Square Pavilion, were part of the nationwide "Fortnight for Freedom" called for by the Ad Hoc Committee on Religious Liberty of the United States Conference of Catholic Bishops. The two-week period began on Thursday, June 21 and ended on Independence Day. On April 12, the Ad Hoc Committee issued a document, "Our First, Most Cherished Liberty," outlining the bishops' concerns over threats to religious freedom, both at home

In his homily, Father Richard noted that we should all be like Jesus, who performed his works of mercy and healing in the public square. "He gave Himself without counting the cost to save those for whom He was sent.

"The day is at hand, brothers and sisters, for you to stand up with Jesus Christ for truth and justice," Father Richard continued. "Our God did not ask the Roman Emperor if he could cure the sick or who he could choose to assist him. God the Son did not check His obedience to the Father at the door of the synagogue to avoid offending the sensibilities of the empire. In his care for others, in the ways of God, Our Divine Savior did not accept that the world's way of serving was the only way he was allowed to serve. The Son of Man placed himself at the service of inconvenient truth and he accepted suffering above the security of his own comfort and life. He did not go seeking a fight with the authorities, but he did not back away from it so that he could live

only to speak the word but not do it. "The day is here, brothers and sisters," Father Richard said. "The U.S. Supreme Court told you that the day has come. The day has come for you to write your legislators to tell them what you want. The day has come for you to hold them accountable for their actions. They are the ones who are responsible.

"Let me be clear about this," he continued. 'In this matter of religious freedom, you cannot depend upon the Court. You cannot depend upon the power of the President. If you want Catholic hospitals, Catholic Charities,

Catholic adoption agencies, Catholic schools, Catholic social services, then you better figure out what these people who are in the Congress are doing and vote for the principles of justice that Jesus lived when stepped upon the earth to save the world.'

At the close of Mass, before the final blessing, Bishop Provost made several comments and alluded to his talk at Saturday's Rally for Freedom. He spoke of the central issue of concern for everyone in this erosion of religious freedom. "In regards to the Health and Human Services mandate," the Bishop said. "It does something that no federal law has done in the history of the United States. It defines what a church is. They call it a 'religious employer.' The church must have as its primary purpose the inculcation of doctrine and it must serve and employ only those of its religious group. This, in and of itself, is very much the heart and center of what our concern should be. The definition is too restrictive. In being so restrictive, Catholic institutions are not exempt from the mandate. Catholic social services do not serve only Catholics. Our Catholic schools and hospitals do not employ only Catholics. This is why the Bishops of the United States voted unanimously to register their protest and why over 40 Catholic institutions filed suit regarding this particular mandate.

"I invite you to become more participatory in this," Bishop Provost continued. "All the information is there for anyone who would seek it, on the website of the bishops and in other sources as well. You will find much to read and much to reflect upon. I commend this to your thoughts and to your prayers as well. Let this prayer and this Fortnight for Freedom heighten our awareness of this very critical issue.

Ronnie Burke, Senior pastor of Maplewood First Baptist Church.
