



Deacon Viau interred at Saint Charles Center

MOSS BLUFF — Deacon Glenn Christopher Viau was interred at New Bethany Cemetery, located on the grounds of Saint Charles Center, on Monday, December 3, following a Mass of Christian Burial celebrated by Bishop Glen John Provost and concelebrated by priests of the Diocese of Lake Charles.

Attending were many deacons of the diocese and elsewhere.

Deacon Viau, 64, of Westlake, passed away suddenly on Wednesday, November 28.

A native of New Orleans, he was born January 17, 1954, where in his adult life was a well-respected Catholic educator, with 14 years in the Archdiocese of New Orleans, as a teacher, assistant principal, and principal.

From 1991 to 2001 and again from 2002 through 2007, he served on the administrative staff at St. Louis Catholic High School as Academic Assistant Principal, Campus Minister, and Academic Administrator. He also taught Theology, English, Social Studies, and Journalism while at the school. He also served as interim principal at Our Lady Immaculate Catholic School in Jennings and as the interim principal at St. Louis for the 2017-18 academic year.

He earned a B.S. in Secondary Education from Loyola University in New Orleans as well as two graduate de-

grees from Loyola, an M. Ed. in Secondary Education and an M.P.S. in Pastoral Studies. He completed the Spiritual Directors program offered by the Diocese of Lake Charles, and served as a supervisor in the program, served three terms as Chairperson of the Council of Deacons, was the Assistant to the Vicar for Clergy at the time of his death.

Deacon Viau taught two Holy Cross theology courses offered through the Diocese of Lake Charles, Morality and Adolescent Faith Development. He served on the teaching staff for the most recent Diaconate Formation Program for the Diocese of Lake Charles, teaching New Testament Letters and Gospels to deacon candidates. He has also taught Introduction to Catholicism and The Catholic Novel for the Center for Catholic Studies. He was currently teaching a dual-enrollment course, Religion 201, at St. Louis Catholic High School through McNeese State University.

Deacon Viau also enjoyed volunteering back to his community through the Covenant House, where he served as an educational tutor, for Hunger Walk-Bread for the World, Spiritual Director for the ACTS Community and with many other organizations.

Deacon Viau was preceded in death by his parents, Louis and Doris Viau; and his in-

He is survived by his wife of twenty-seven years, Rosalie Sparacio Viau of Westlake; daughter, Christina "Tina" Burleigh and husband Phillip, also of Westlake; sister, Deborah Viau Valiente and husband Joseph; nephew, Stephen Valiente; niece, Kristen V. Romig and husband Neil; grandchildren, Brooks, Brennum, and Brecken Burleigh; and his beloved granddoggie, Lucy.

Fight against human trafficking ongoing

Work continues to combat human trafficking, one of the most insidious new forms of slavery in the world today and to be found in the midst of Southwest Louisiana.

The average age of a trafficking victim is 13 years and 89 percent of the slaves are sold into the sex industry.

The Louisiana Summit on Modern Slavery and Human Trafficking examined methods to fight this horrendous sin, looking at roles and best practices in government, law enforcement, churches and non-governmental organizations in eradicating this crime against humanity.

The conference was hosted by Bishop Marcelo Sanchez Sorondo, Vatican

Chancellor of the Pontifical Academy of Sciences and Pope Francis' delegate to fight "modern slavery," along with Louisiana Governor John Bel Edwards, Texas Congressman Ted Poe and the congressional caucus against victims of abuse, along with Father M. Jeffery Bayhi, founder of

Metanoia Manor, a shelter for victims of human trafficking.

"The problem is growing in the world," said Bishop Marcel Sanchez Sorondo, the Chancellor of the Pontifical Academy of Sciences. "We need to eradicate human slaves and human trafficking."

This was Bishop Sorondo's second trip to Louisiana as he had been present in 2017 for the dedication of Metanoia Manor, the home built to house and rehabilitate teen

human trafficking victims. Four such survivors were residing at the home at its

dedication, which is staffed by nuns trained to serve this special population.

Diocese of Lake Charles compliant with Charter

LAKE CHARLES -- In November, the Diocese of Lake Charles was audited for its compliance with the *Charter for the Protection of Children and Young People*. Bishop Glen John Provost has announced "that this most favorable audit report from Stonebridge states that the Diocese of Lake Charles is in compliance with the *Charter for the Protection of Children and Young People* and is a further testimony to our continuing efforts to insure the safety of our children and youth."

The on-site audit performed here in the Diocese by Stonebridge Business

Partners was for the 2017-2018 audit period.

The *Charter for the Protection of Children and Young People* is a comprehensive set of procedures originally established by the United States Conference of Catholic Bishops in June 2002 for addressing allegations of sexual abuse of minors by Catholic clergy. The *Charter* also includes guidelines for reconciliation, healing, accountability, and prevention of future acts of abuse. It was revised in 2005, 2011, and 2018.

The following are measures required by the *Charter* and in which the Diocese

of Lake Charles is fully compliant:

- Creating a safe environment for children and young people;
- Healing and reconciliation of victims and survivors;
- Making prompt and effective response to allegations;
- Cooperating with civil authorities;
- Disciplining offenders;
- Providing for means of accountability for the future to ensure the problem continues to be effectively dealt with through the Secretariat of Child and Youth Protection and the National Review Board.

Cathedral radio broadcast to go on hiatus

LAKE CHARLES -- Beginning with the first Sunday of January, the Feast of the Epiphany, the radio broadcast of the celebration of the Sunday 9:30 a.m. Mass from the Cathedral of the Immaculate Conception will be temporarily off the air.

This temporary cessation of the airing is due to the closure of the Cathedral to continue the inside renovation of the building. All Masses after January 2, will take place in Ave Maria Hall, located across the street from the Cathedral at the southeast corner of Kirby and Bilbo streets.

Plans call for the radio broadcasts to recommence once the inside work has been completed and the Cathedral reopens, hopefully in July 2019.

When broadcasts return, the Mass will still be available each Sunday on KLCL (1470-AM) and KJEF-AM (1290-AM) in Jennings as well as on Radio Maria 91.1 FM on the second Sunday of each month.

LAKE CHARLES -- Father Nathan Long will teach on the Letters of St. Paul Course Title: The Letters of Saint Paul on the Tuesdays of January 29 and February 12, 19, 26 from 5:30-7:30 p.m. at the Catholic Student Center at McNeese.

The course description is as follows: "St. Paul is notoriously misunderstood. St. Peter admitted as much in his own letter (2 Peter 3:15-16). Yet, understanding St. Paul is critical if we are to take seriously the call to evangelize. After all, Paul was the first world-wide evangelizer. Moreover, his epistles are read throughout the year in the Sacred Liturgy. Few pay much attention, and they are rarely given attention from the pulpit. In the interest of making the most of a short time, the approach in this course will be to take 8 keys/keywords to recall the central ideas and themes in Paul. By developing an understanding in these topics, it will better equip the participant to hear and understand the sections of Paul's epistles as they are read at Mass."

Paula Hunter will teach Theology of the Body and the Interior Life on the Tuesdays of March 12, 19, 26, April 2, 9, 16 from 5:30-7:30 p.m. at the Student Center.

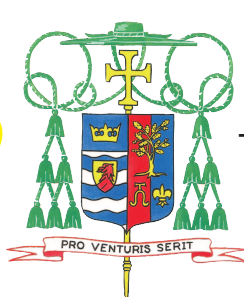

Return to the Lord - Camp Karol construction

MOSS BLUFF - Work continues, through the generosity of contributors to the *Return to the Lord* Capital Campaign, on construction of The Lodge, the multi-purpose center of all future activities for Camp Karol, nestled among nature and provide a serene environment for Catholic youth of the Diocese of Lake Charles seeking Christ, live Catholic, build community, and ignite the World.

Part of the plan for Camp Karol, originally designated as Phase 2, is the construction of overnight housing facilities, namely 12 bungalows costing about \$81,000.00 each. Through the generous contribution of \$324,000.00 by Chad and Michelle Mudd to ongoing fundraising efforts, construction of four of those bungalows will begin soon at the site allowing the housing of participants on the grounds of Camp Karol to coincide with the opening of the doors of "The Lodge" and the kick off of programming at the facility.

The youth retreat center will provide spiritual direction, faith-filled talks, and instruction in Catholic beliefs. It will light a spark in the hearts and minds of young people. The motto of Camp Karol is *Totus Tuus*: Totally Yours.

"The significance of the name is that Camp Karol is named in honor of Saint John Paul II whose birth name was Karol Wojtyla," said Deacon Brian Soileau. "In Polish, his native language, Karol means Charles. This underscores the strong link Camp Karol has to Saint Charles Center and Tabor Retreat House.

According to Deacon Soileau, the Associate Director of Saint Charles Center, the idea of a Catholic youth camp in Southwest Louisiana was first broached by a group of concerned Catholic men about their children. It came with the group's purchase of Bear Island, a beautiful piece of land in Moss Bluff situated along the Calcasieu River, in 2008 and the group's subsequent effort to raise funds and seek in-kind contributions to build a facility for Catholic youth.

Bishop Glen John Provost placed the project under the direction of Father Whitney Miller, director of Saint Charles Retreat Center. The donation of 89 acres of property by Camp Karol, Inc. along with related assets, to the Diocese of Lake Charles



came in early 2016. The vision evolved into Camp Karol and expanded to include additional acreage near Bear Island.

Deacon Soileau noted a number of ways that individuals can help including Prayer - pray for the success of the Camp Karol project, the people working with it, and its mission. While praying, ask for the intercession of the Blessed Mother, Saint John Paul II, Saint Charles Borromeo and Saint Peter Claver; Time - throughout the building phases, we will need volunteers. We urge you to consider giving your time and energy; Talents - whether your talent consists of carpentry, arts, cooking, etc., these may be needed for the completion of Camp Karol; and Funding - your monetary donations are greatly appreciated and will be used for the various phases.

Some of those phases include the bungalow construction and furnishings, Bear Island equipment, boardwalk construction along with Chapel construction and furnishings.

Contributions can make any number of items possible to acquire including Lodge furnishings - folding chairs - \$30 per chair (200 chairs); folding tables - \$90 per table (20 tables); folding, rolling, dining room tables - \$1,100 per table (12 tables); office desks - \$600 per desk (2 desks); conference room table and chairs - \$2,000 (1 set); entrance lobby furnishings - \$10,000; sound system for conference hall - \$12,000; kitchen/dining supplies - \$10,000; landscaping - \$20,000; and chapel liturgical supplies - \$10,000.

Overnight accommodations made up of eight bungalows will be constructed at a cost of \$81,000 each.

The Bear Island aspect of the project includes boardwalk - \$50,000; clearing of Bear Island - \$50,000; ropes course - \$20,000; sports fields - \$10,000; and wharves and canoes - \$10,000.

The site clearing for The Lodge began in October with the felling of numerous trees. Later, after the removal of the trees, site work brought truckloads of dirt onto the property to build up the pad for the building. More recently, work continued in preparation for the pouring of concrete for the building's foundation, which is hoped for in early 2019.
