One Diocese, One Church: Hurricane recovery showing signs of progress

A lot has happened in the Diocese of Lake Charles since Hurricane Laura made landfall just over six months ago.

Displaced priests have settled in more permanent housing. Temporary campuses have been set up at two of the three heavily damaged schools. Christ the King Parish is "home" after sharing worship space at Our Lady Queen of Heaven Catholic Church. Saint Charles Center is back in the retreat business after serving as a short-term residence for clergy and seminarians.

These are just a few examples of progress since Laura spread her catastrophic destruction from the coastal churches in Cameron Parish to as far north as churches in Allen and Beauregard parishes on August 27, 2020.

Father Ruben J. Buller said the Hurricane Recovery Team has made great

"We have been able to assess all of our damages across the diocese at 65 sites. That includes 39 church parishes and all six schools," said Buller, who serves as Chief of Recovery while also continuing in his role as Vicar General. "We estimate the damages at \$110 million."

Buller said there are a total of 508 projects that the recovery team is working on that will fall into categories of repair, re-

"The things that are repairs are beginning slowly, but they are beginning," he said. "It is still too early to say what structures will be rebuilt at this point. Those decisions are still in the early phases of the process.'

The recovery effort has taken on a central theme: "One Diocese, One Church." For that purpose, Father Buller said the

recovery is thought of in terms as one building project rather than multiple projects everywhere.

"We are all in this together," he said. "The ability of a particular church to be able to address its own needs is different from one location to the other. Thinking of this project as 'One Diocese, One Church,' which is what we are in a sense, we will be able to ensure that there is a wholeness in each of the locations."

"Some of the parishes that are more well off will be bearing a little more of the brunt of their own costs," continued Buller, "so that smaller parishes, or parishes that are not as wealthy will be able to have more support.'

Meeting with all the pastors and all the principals of the schools is something that Father Buller considers one of the biggest areas of progress in these past several months.

"They are the ones who are boots on the ground, so we proposed the question: What is that you see that will be best for your location? Some of them are in the midst of looking at proposals they will be making," Buller said. A mammoth task such as rebuilding an

entire diocese spanning five civil parishes does not come without challenges. Being hit by Hurricane Delta six weeks after Laura was not what the crippled diocese "To be hit by a second hurricane so quickly put us back at square one," Buller

said. "The biggest thing that Delta did was exacerbate the situation. The recent ice storm also brought its own level of difficulties piled on to hurricane damages."

Another obstacle was setting up temporary campuses at three school sites. Buller said the recovery team was fortu-

nate to get St. Louis Catholic High School open quickly in the fall, and most recently, St. Margaret of Scotland Catholic School. Students in grades 5-8 had been sharing space at Immaculate Conception Cathedral School through mid-February.

"The challenges at Our Lady's School in Sulphur have been a bigger hurdle to cross," said Buller. "It's not anyone's fault. The type of dirt the campus sits on does not support temporary buildings, so that has to be addressed first before we can put the campus in place."

With the beginning of the 2021 hurricane season less than three months away on June 1, one of the things the recovery team is working on is making sure the diocese's insurance policy will be reflective of what is needed to rebuild for a named storm should a catastrophic storm strike the area again.

Until the policy renews on July 1, added coverage of \$30 million for a named storm was purchased to protect the diocese through June 30. It had already met the current policy's limit of liability.

Working with the insurance company as well as our own people is a big process. It will take from now until our policy is renewed to get all that situated," Buller said. "If we up the coverage, we have to up the premiums. It's a balance that we have

Father Buller said the repairs, restoration, and rebuilding could realistically take up to five years.

"We just want to start checking off those 508 projects one at a time," he said. "Our goal is to bring health to our diocese



Bishop Provost to preside at Sacred Triduum in Cathedral

LAKE CHARLES - The Most Reverend Glen John Provost will celebrate the Sacred Triduum - Holy Thursday, Good Friday, and Easter Vigil - in the Cathedral of the Immaculate Conception.

On Palm Sunday, March 28, Bishop Provost will bless the palms before the 9:30 a.m. Mass in the Cathedral. Palms will also be blessed at the 5 p.m. Extraordinary Form Mass that day.

The Bishop will also be the celebrant of the Chrism Mass in the Cathedral at 10 a.m. on Wednesday, March 31, with the priests of the Diocese as concelebrants. At this Mass, the Holy Oils - Oil of the Sick, Oil of the Catechumens, and the Oil of Chrism used during the year are prepared and blessed.

The Mass of the Lord's Supper is celebrated on Holy Thursday, April 1, at 7 p.m. It is at this Mass where the commemoration of Christ's washing the feet of His Apostles is re-enacted. Following the Mass, the Blessed Sacrament will be available for Eucharistic Adoration until midnight. Earlier in the day, at 8 a.m., there will be morning prayer in the Cathedral.

The Commemoration of the Lord's Passion will take place on Good Friday, April 2, at 3 p.m. The service begins with the Liturgy of the Word, followed by Veneration of the Cross with the faithful recognizing the "Cross of Christ" as their only hope of salvation. The celebration concludes with Holy Communion.

On Good Friday there will be morning prayer at 8 a.m. followed by a Walk with Christ from the Cathedral to the Old Catholic Cemetery and back, praying the Stations of the Cross, the Holy Rosary, and the Chaplet of Divine Mercy.

The Easter Vigil on Saturday, April 3, will begin at 8 p.m. in the Cathedral with the Service of Light outside the church.

Cathedral Mass times for Easter Sunday, April 4, are 7:30 a.m., 9:30 a.m., and 11:15 a.m., with Mass in the Extraordinary Form

Diocesan office hours for Holy Week are 8:30 a.m. to 4:30 p.m. Monday through Wednesday, March 29-31. Offices will be closed on Holy Thursday and Good Friday, April 1 and 2, as well as Easter Monday, April 5. They reopen on Tuesday, April 6 at 8:30 a.m.

Nearly 400 scholarships available in Diocese of Lake Charles Schools

Deadline to apply is April 15

Lake Charles – Up to nearly 400 students will have an opportunity to earn scholarships to attend Catholic schools this Fall within the Diocese of Lake Charles, thanks to the generosity of a patron giving a \$1.8 million donation. The family, who wishes to remain anonymous, made the generous gift through ACE Scholarships, which provides children of low-income families access to quality education through its scholarship program.

"This incredible gift to our community comes at a time when Southwest Louisiana families are most profoundly in need, and this patron's investment in their future is evidence of deep faith in the educational excellence of our diocesan schools," said Bishop Glen John Provost. "Because of this generosity, families unable to afford Catholic school will find the assistance they need to make the best choice for their children. Students in grades K-8 receive up to \$4,200 and students entering grades 9-12 receive up to \$4,500 toward tuition. Families interested in applying for tuition assistance through ACE Scholarships must apply for enrollment at their school of choice and apply separately for a scholarship through ACE at https://www.acescholarships.org/become-a-scholar/louisiana/.

The deadline to apply for a scholarship for the 2021-22 academic school year is April 15, 2021.

Insurance and Hurricanes

Every year, the Diocese of Canada. Lake Charles reviews and analyzes the property liability insurance for every school, parish, building and department within its five-parish territory. All structures and entities are combined for insurance coverage for economies of scale, bigger discounts and spreading of risk.

The Diocese currently partners with the Catholic Mutual Group (CMG) to obtain this coverage. CMG is an organization that is a part of the Catholic Church that focuses on providing more affordable insurance than can be found in the commercial insurance markets. It was founded by a group of Bishops in 1889 and provides insurance coverage for over 125 dioceses and archdioceses in North America and 200 Catholic Religious Orders and Institutions in the U.S. and

As part of the annual review, CMG engages an independent third party who conducts a named storm analysis. This is taken into consideration every year as the Diocese of Lake Charles collaborates with its insurance partner to assess costs and benefits of coverage levels and premiums.

The "named storm limit" of coverage for the Diocese is \$30 million. In the most recent named storm analysis that was received and reviewed in the Spring of 2020, the report details every named storm and its corresponding damage experience in the Diocese of Lake Charles over the past 100 years. The total damages from all of the top 20 storms combined, before Laura and Delta, are only \$42 million.

In 2005, when Hurricane

Rita made landfall as a Category 3 storm in Cameron Parish, the Diocese was covered with a "named storm limit" of \$20 million. According to GC Analytics, the ground-up loss was over \$4 million, well below the \$20 million coverage limit in place at that time. Rita was the strongest storm in 48 years on record to hit Southwest Louisiana. Hurricane Audrey was the all-time highest damage storm to hit our area in 1957 with losses totaling a little more than \$8

million. Taking a prudent approach moving forward, the Diocese increased its "named storm limit" to \$30 million and continued doing so for the next 15 years. The annual premium in 2020 was over \$1 million for this coverage.

The analysis, conducted by GC Analytics, estimated a hurricane loss of approximately \$15 million every 1 in 100 years (or 1% chance in 2020), and further showed only a 1% probability that another loss of Category 3 strength would exceed \$29 million.

Hurricanes Laura and Delta caused \$110 million in damages to the properties of the Diocese of Lake Charles. This is off the charts and defies any historical trends and future modeling of any insurance "experts." The chances of the Diocese suffering two back-to-back storms was considered "inconceivable" by the experts. Their projections and recommendations were literally blown away.

Rest assured, the Diocese will be taking all of this into consideration as it works towards the renewals for property insurance this spring.

Diocese in compliance with Charter

LAKE CHARLES — Based on the analysis of data collection results of the 2019/2020 Charter audit period of the Diocese of Lake Charles, the diocese has been found to be in compliance with the requirements for the Charter for the Protection of Children and Young People, approved by the U.S.

bishops in 2002.

Bishop Glen John Provost was informed of the finding in a letter, dated January 18, 2021, from Stonebridge Business Partners which is the company that conducts independent audits of dioceses across the country. The letter thanked the diocese for its cooperation and for participating in the data collection process. An onsite audit is scheduled for the Diocese of Lake Charles in 2021.

The Charter for the Protection of Children and Young People is a comprehensive set of procedures originally established by the United States Conference of Catholic Bishops in June 2002 for

addressing allegations of sexual abuse of minors by Catholic clergy. The Charter also includes guidelines for reconciliation, healing, accountability, and prevention of future acts of abuse. It was revised in 2005, 2011, and

Catholic Charities partners with city

LAKE CHARLES — Catholic Charities of Southwest Louisiana is partnering with the City of Lake Charles to help residents pay overdue water bills.

The idea originated from the city's concern over the high volume of water bill accounts becoming extremely past due in light of economic

Sister Miriam MacLean, R.S.M., director of Catholic Charities, said the nonprofit agency has always been committed to helping people through difficult times and get them back on their feet.

"It is such a gift that we are able to have another resource through the city to help people be able to keep their water on," said Sister Miriam. "Dealing with two hurricanes, we know what it's like to not have water here in Lake Charles."

The water/sewer utility service bill payment assistance program is funded by the city and managed by Catholic Charities for the benefit of customers in Lake Charles who have been adversely affected by COVID-19. The temporary hold on water disconnections is coming to

Catholic Charities will assist with \$200 per household or three months of delinquent water bills between March and November of 2020, whichever is greater. Assistance will only be granted once per household.

Even though so many people are suffering and tired, especially after the hurricanes, Sister Miriam said the water assistance program offers a little sign of hope and some normalcy, which is not a lot these days.

"From a faith perspective, we might ask what is the normalcy we are looking for? It is these ways of helping one another," Sister Miriam said. "We are ultimately growing in faith and growing in our love for the Lord and allowing this to be an opportunity to grow in virtue. Catholic Charities is ex-

pecting to be able to help between 400-500 citizens with past due water bills. The following information

Sister Miriam said qualifying for the water assistance program through the partnership does not disqualify someone from other types of assistance offered by Catholic Charities. However, a household won't be able to apply for additional assistance at the same time. "Because we expect a high

volume from this partnership, people will need to apply at a later time to be assessed for other needs," said Sister Miriam. Catholic Charities helps

with rental and mortgage assistance, food and utilities, funeral expenses, prescription medication and TWIC assistance. Clients are seen by appointment only.
