## Catholic Schools' 2022-2023 Calendar

Catholic schools in the Diocese of Lake Charles will begin the 2022-2023 school year with the return of students at the five schools located in Calcasieu Parish on Wednesday, August 17.

Students at Our Lady Immaculate Catholic School in Jennings will make the transition back to classes over several days with girls in grades 1-8 returning on Wednesday, August 10; boys in grades 1-8 returning on Thursday, August 11; and PK3, PK4, and Kindergarten students going back to class on Monday, August 15.

Calcasieu Parish schools include St. Louis Catholic High School, Immaculate Conception Cathedral School, St. Margaret of Scotland Catholic School, and Our Lady Queen of Heaven Catholic School, all in Lake Charles; and Our Lady's Catholic School in Sulphur. Our Lady Immaculate is in Jefferson Davis

Holidays during the school year — days the students are not in attendance - include:

- Labor Day: Monday, September 5
- All Saints Day: Tuesday, November 1
- Thanksgiving: Monday, November 21 to Friday, November 25
- Christmas: Monday, December 19 to Friday, December 30
- Dr. Martin Luther King, Jr. Day: Monday, January 16
- Mardi Gras: Friday, February 17 to Tuesday, February 21 (Calcasieu schools); and Monday, February 20 to Wednesday, February 22 (Our Lady Immaculate)
  - St. Patrick's Day: Friday, March 17
  - Easter: Friday, April 7 to Friday, April 14

An additional holiday for Our Lady Immaculate will be the Jefferson Davis Parish Fair Day on Friday, October 7.

In-service days for teachers and staff include October 10 and January 2. The last day of classes for OLI students will be Friday, May 19; and Thursday, May 25, for Calcasieu schools.

## Diocese provides services to new parents & students

21, 2022, Bishop Glen John Provost approved the creation of a policy for maternity and paternity leave for the Diocese of Lake Charles and associated entities, including the parishes and Catholic Schools. The Bishop appointed the Director of Fiscal Affairs, Mr. Jacob Troutman, and the Vicar General for Administration, Fr. Ruben Buller, to oversee the creation of the particulars of the policy, which is envisioned to take effect in July 2023.

The Catholic Schools in the Diocese of Lake Charles also provide resources for students with special needs. Partnering with the St. Nicholas Center for Autism and other agencies, our Catholic Schools serve students with autism. Our Catholic schools participate in the Louisiana Department of Education's "School Choice Program for Certain Students with Exceptionalities," which provides tuition assistance to families of students with special needs who desire private education. All our Catholic schools enroll students with special needs. Two have progression programs, a service dedicated to students with special needs; Immaculate Conception Cathedral School and St. Louis Catholic High School both provide individual classroom instruction and tailored resources.

O Virgin, Star of the Sea, Our Beloved Mother, we ask you to plead with your Son on our behalf, so that spared from the calamities common to this area and animated with a true spirit of gratitude, we will walk in the footsteps of your Divine Son to reach the heavenly Jerusalem where a stormless eternity awaits us. Our Christian values, not to mention human decency, prompt us to act civilly and protect human life both born and unborn?

### DIOCESAN RECOVERY UPDATE

Nearly two years have passed since Hurricane Laura made landfall on August 27, 2020, as a Category 4 hurricane in Southwest Louisiana with 150 mph winds and over nine feet of storm surge.

More than 500 structures in the Diocese of Lake Charles alone, that is Catholic church structures, in five civil parishes, were affected with an estimated \$135 million in total damages.

Recovery was in its beginning stages when, only six weeks later, Hurricane Delta slammed into much of the same area. Then a winter ice storm in February of 2021 struck, and a few months later in May, residents suffered through yet another storm that included devastating flooding.

What follows is the first in a series of monthly snapshots highlighting the ongoing recovery in the Diocese of Lake Charles:

Requirements to receive a window unit air conditioner are: age 65 or older OR disabled; low income; proof of residency (utility bill or rental lease in applicant's name), need for a window unit air conditioner (cannot have central air or already own a window unit).

All applicants must call Catholic Charities at 337-439-7436 to begin the application process. No applications will be taken in person. After initial telephone interview and a scheduled appointment with Catholic Charities, the Knights of Peter Claver will do a home inspection. If approved, the Knights will install the unit in the home.

## New Life Counseling offers more options to choose life

**Diocese of Lake Charles** LAKE CHARLES — There have been more than 4,000 babies' lives saved since New Life Counseling opened its doors in 1984. The pregnancy resource center located at 631 East School Street has expanded its services to save

even more innocent lives. Life Counseling announced in May two new through offered services New Life Medical Services. Clients now have free access to Abortion Pill Reversal and STI Testing/Treatment for sexually transmitted infections. These are in addition to the other free services of pregnancy testing, ultrasounds, and counseling.

"Timing is key when it comes to the success of Abortion Pill Reversal," said Tabitha Dugas, Executive Director of New Life Counseling. "The effectiveness is based on time. We must get to these women within 72 hours of taking that first abortion pill (also known as RU-486). This is a way that we can save more babies. Abortion Pill Reversal

is relatively new but it is effective, Dugas noted, which is why she is eager to spread the word to any women who finds themselves wanting to save their pregnancy.

"Statistics from Abortion Pill Rescue Network show that 3,000 lives, and

in America from the use

of Abortion Pill Reversal.

so getting the word out is a priority," Dugas emphasized. "APRN also reports that 150 women start the reversal process every month."

'The biggest issue for me is that first, we are the only ones in this area who offer the option of Abortion Pill Reversal; and second, we offer it free of charge. That is huge," said Dugas. "Normally, this could be up to a \$700 or \$800 cost that a woman could incur."

In response to the news of the U.S. Supreme Court's overturn of Roe v. Wade, the 1973 landmark case that legalized abortion nationwide, Dugas said New Life Counseling's focus remains the same. "New Life Counseling

stands as a ministry of hope in a world that is saturated with false promises of happiness. For nearly 38 years, because of this community's support, we have been constantly adapting our message of life to the newest generation," said Dugas. "With relevancy, we are able to engage the youth of today with hope for the future. We choose to lead with grace but empower with truth. Politics will never change that."
